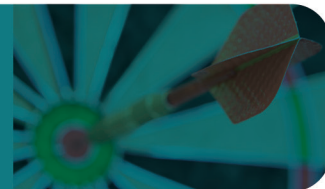

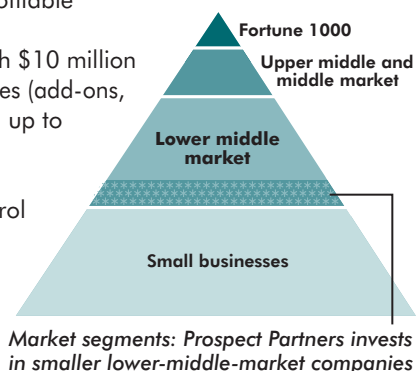


The Small Company Specialist

Our Investment Criteria

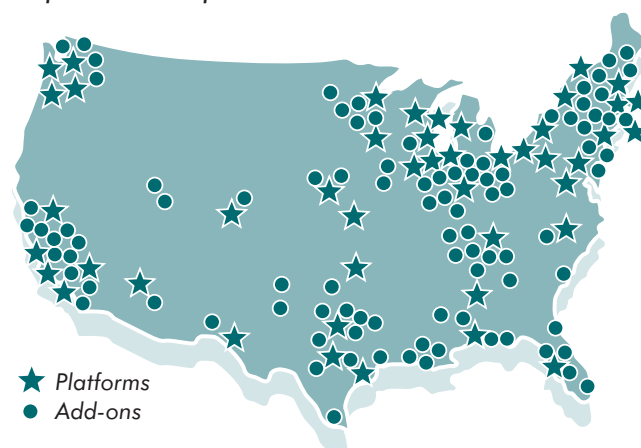
- Companies in the United States
- Companies in a broad range of niche markets, including manufacturing, distribution, and specialty business, consumer, healthcare, and industrial services
- Companies that are, or could become, that market's leader
- Companies that are profitable and growth-ready
- Companies typically with \$10 million to \$75 million in revenues (add-ons, at least \$2 million) and up to \$8 million in EBITDA
- Companies looking to provide a majority control position in which additional capital is available to support organic growth and/or acquisitions
